Jim R. - has the electricity comparison from 2013-2014 through February 2014. Focus on the energy that is saved since the cost of energy can change and we don't really have control once the price is set through the contracts

Natural gas is costing a bit more this year due to the long, cold winter.

Based on Jim's research: 295,000 KW or approximately \$41,504.89 was saved this year compared to last year

On the EPA.gov site you can see the savings (e.g., equivalent to XX trees saved)

Many things can affect electricity usage: fixture retrofits, weather/temperature,
effects electricity,

Sue is working on a new program for the District that will allow more analyze Having this data will tell us when we are "off track" and provide us a baseline for future decisions
